With reference to the cited above subject the Mahesh Foundation building consisting Ground Floor + 4 upper floors at 792/1, Opp. Govt Kannada School, Siddeshwar Nagar, Kanabargi, Belagavi District was inspected by me on 23/01/2022 with respect to Fire prevention, Fire fighting and Evacuation measures to be complied in the above premises and has submitted the details as under.:

At least two fire service inlets to boost the water in the riser directly from the mobile pump should also be provided. These inlets should located easily at an accessible position, preferably the entry point to the premises. down comer Each system should be connected to an overhead tank of minimum 10000 ltrs. capacity and along pump of 450 lpm capacity. From the above details it is clear that the 'Management' of the above building have been advised to display escape routes & fire safety plans, and to arrange 40% of the staff/occupants/tenements to undergo basic fire fighting training at R.A.Mundkur fire & Emergency Services Academy, Bannerughatta road, Bangalore. After full-filling the above recommendations, a Certificate should be obtained by this office. If at any time any of the conditions are found not complied with, this Certificate shall stand withdrawn/cancelled.

Hence, this Advice cum safety certificate is issued for the Mahesh Foundation building consisting Ground Floor + 4 upper floors at 792/1, Opp. Govt Kannada School, Siddeshwar Nagar, Kanabargi, Belagavi District.

This Certificate is valid for a period of one year only from the date of issue of this letter.
